Can you have a Misdemeanor Expunged in Indiana? Absolutely. All misdemeanor charges can be expunged under Indiana's Expungement law. This includes Class D felonies (for any crime committed before July 1, 2014) and Level 6 felonies (for any crimes committed after June 30, 2014) that were reduced to a misdemeanor in a plea agreement (via Alternative Misdemeanor Sentencing or AMS).
